

ORDER FOR LOCATION OF CONDUITS AND MANHOLES

Whereas, **NSTAR ELECTRIC COMPANY d/b/a EVERSOURCE ENERGY COMPANY** has petitioned for permission to construct a line for the transmission of electricity for lighting, heating or power under the public way or ways of the City of Framingham, and notice has been given and a hearing held on said petition as provided by law. **IT IS HEREBY ORDERED**

That **NSTAR ELECTRIC COMPANY d/b/a EVERSOURCE ENERGY COMPANY** be and hereby is granted permission to construct and a location for, such a line of conduits and manholes with the necessary wires and cables therein under the following public way or ways of the City of Framingham:

CONCORD STREET: At Kendall Street southerly from manhole MH11117 thence turning westerly approximately 68 ± feet - conduit

Reason: To provide underground electric service to 82 Concord Street.

All construction work under this Order shall be in accordance with the following conditions:

- 1. Conduits and manholes shall be located as shown on the plan made by **A. Debenedictis, Dated June 07, 2019**, on file with said petition.
- 2. Said company and proposed work shall comply with requirements of existing bylaws and such as may hereafter be adopted governing the construction and maintenance of conduits and manholes.
- 3. All work shall be done to the satisfaction of the City Council or such officer or officers as it may appoint to supervise the work.

The foregoing permission is also subject to the conditions set forth in a letter dated August 22, 2019 from the Framingham Department of Public Works as follows:

- A. The conduit shall be encased in cement concrete.
- B. This segment of Concord Street was recently paved (less than 5 years) heighten roadway restoration shall applied at the time of Street Opening Permit issued.
- C. The applicant shall obtain a Street Opening Permit and a Trench Opening Permit for this work.
- D. DPW requests notification prior to the start of work to verify final location in the field and that no public utilities are adversely affected.
- E. The applicant and contractor shall endeavor to maintain 10-foot separation from city-owned utilities at all times.
- F. The applicant shall submit a traffic management plan to DPW for review and approval prior to construction.
- G. The applicant shall fully replace and restore all sidewalk, curbing, and roadway infrastructure impacted by this work.
- H. All work shall conform to the City of Framingham construction standards.

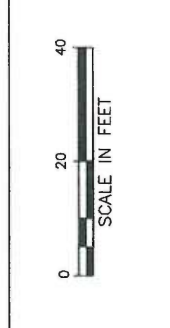

Dear City Council,

The Department of Public Works (DPW) is in receipt of a request from EVERSOURCE ENERGY to locate a conduit along the roadway on Concord Street as represented under submitted Grant of Location application package dated July 15, 2019. In addition, DPW is in receipt of a letter (as attached) from EVERSOURCE ENERGY documenting that there are no other alternatives to route the electrical service to this address. The conduit shall be owned and maintained by the Petitioner.

We have reviewed this Grant of Location request submitted to the City Council and recommend approval subject to the following conditions:


Re: 82 Concord Street, Framingham MA

Dear Mr. Johnson,

The service requirements for the project at 82 Concord Street, Framingham exceed the capacity of the existing service connection. In addition, due to these service requirements and the lack of space behind the building at 82 Concord Street, a new service connection from Franklin Street is not feasible. Therefore, the installation of an additional 4" conduit in Concord Street will be required as depicted in the plans previously submitted to the city for approval.
