Be it ordained by the Framingham Council, as follows:

Establish A Commission to Identify A Location for, Masterplan for implementation, and an Ordinance for the Operation of a Dog Park in Framingham.

SECTION 1.

Dog Park Commission

A. Dog Park Commission. The Dog Park Commission shall consist of seven (7) members, selected as follows: Chair of Park and Recreation Commission, whom shall serve as chair, Chair of the Conservation Commission, Chair of Council economic development subcommittee, President of FramBARK, City Clerk, a Framingham dog owner appointed by the Chair of the Council, and a Framingham veterinarian appointed by the Mayor.

B. Purpose. The Dog Park Commission's purpose is to identify suitable public property for a dog park, outline a masterplan for its implementation, including a detailed budget, and recommend policies and procedures for its operation.

C. Membership, Terms and Vacancies. All members of the Commission will hold said position until each no longer serves in the position that resulted in the member's selection. Any vacancy in the membership of the Commission not filled by each respective organization shall be filled by the Mayor.

D. Staff: The Parks and Recreation Department shall staff the Commission unless the Mayor shall assign a different staff liaison to the Commission.

E. Report. Said Commission shall deliver its report, along with detailed recommendations, to the Mayor and Council within 90 days of its formation.

SECTION 2.

If any provision of this resolution shall be held to be invalid by a court of competent jurisdiction, then such provision shall be considered separately and apart from the remaining provisions, which shall remain in full force and effect.

SECTION 3.

Effective Date.

This resolution shall take effect upon its adoption.
