ORDER NO. 2020-100 REQUEST OF THE TRAFFIC COMMISSION

UPON THE REQUEST OF THE TRAFFIC COMMISSION, THE CITY OF FRAMINGHAM, THROUGH THE FRAMINGHAM CITY COUNCIL, IT IS SO ORDERED:

That, in accordance with the favorable vote of the Traffic Commission on June 23, 2020, the City Council now votes to rescind the existing No Parking restriction on the even side of Shawmut Terrace from a point at 34 Shawmut Terrace proceeding west to the parking lot entrance to Learned Pond as depicted on the attachment. All documentation is also available from the Traffic Commission.

Use of this new parking area shall be in accordance with all applicable bylaws, ordinances and statutes of the City of Framingham and the Commonwealth of Massachusetts.

IT IS FURTHER ORDERED:

Pursuant to Article V Section 6 of the Framingham Home Rule Charter, Schedule 1 (No Parking) of Article V Section 2 of the Framingham Traffic Rules and Orders, originally adopted on September 9, 1973, shall be amended by removing:

<u>Street</u>	<u>Side of Street</u>	<u>Extending From</u>
Shawmut Terrace	Both	#34 Shawmut Terrace to end of lake

And modifying the language to state:

<u>Street</u>	<u>Side of Street</u>	<u>Extending From</u>
Shawmut Terrace	North	Robertson Road to end of lake

Pursuant to the Framingham Home Rule Charter, Article V Section 6, all rules and regulations promulgated by authorized vote of the Traffic Commission shall become effective on the 30th day following the day on which notice of proposed rule or regulation is filed with the council, unless the council shall within such period by majority of the full council vote to reject such rule or regulation or has sooner voted to affirm it. In accordance with the council's vote, this change is effective on November 28, 2020.


