### ORDER FOR POLE RELOCATION

By the City Council of the City of Framingham, Massachusetts, notice has been given and a public hearing held, as provide by law, **IT IS HEREBY ORDERED:**

That permission be and hereby granted **VERIZON NEW ENGLAND, INC.** location for and permission to erect and maintain poles and their respective wires and cables to be placed thereon, together with anchors, guys, and other sustaining and protecting fixtures as said Company may deem necessary, in the public way or ways as requested in petition of said company dated the 27<sup>h</sup> day of February 2018.

**CONCORD STREET:** Relocate one (1) solely owned pole numbered T.150-1 in a northeasterly direction a distance of approximately ten (10) feet to a point on the northeast corner of the intersection of Concord Street and A Street.

1 pole to be relocated


All construction under this order shall be in accordance with the conditions set forth in a letter dated March 23, 2018 from the Framingham Department of Public Works as follows:

1. The applicant shall call Dig-safe to mark out the location of the water main before construction.
2. The proposed relocation of existing utility pole shall be installed a minimum five feet away from City utilities. The DPW requests notification prior to the start of work to verify final location in the field.
3. All work shall confirm to the City of Framingham construction standards.
4. The proposed work shall be inspected by the City of Framingham DPW to verify that no public utilities are adversely affected.
5. The area in the vicinity of the work shall be restored and all excess excavation resulting from pole setting shall be removed by the Grantee.

The following general conditions shall also apply: Poles shall be of sound timber and reasonably straight, and shall be set substantially at the points indicated upon the plan marked – **VERIZON No. 1A2N4PC** dated February 27, 2018 filed with said petition. There may be attached to said poles by the said Company not to exceed 20 wires and 5 cables and by said any such wires, cables and fixtures as are necessary in its business and all of said wires and cables shall be placed at a height in compliance with the National Electrical Safety Code.

Also, that permission be and hereby is granted said **VERIZON NEW ENGLAND, INC.** to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as it may desire for distributing purposes.



# PETITION PLAN



