That, based on City Solicitor opinion that the City Council has jurisdiction over Board of Selectmen policies and a unanimous vote to reconsider the vote of November 19, 2019, the City Council votes to amend the Board of Selectmen Policy for the Regulation of Taxicabs/Livery Vehicles and the Operation Thereof in the Town of Framingham, Article 5, Section 4, Taxi/Livery Fees as follows, with an effective date of January 1, 2020:

- Permit to operate taxi/livery company -- \$250
- Vehicle for hire license fee - \$0
- Vehicle inspection fee -- \$0
- Operator's license fee (hackney) - \$30
