## ORDER NO. 2022-056-002 REQUEST OF THE FINANCE SUBCOMMITTEE

UPON THE REQUEST OF THE FINANCE SUBCOMMITTEE, THE CITY OF FRAMINGHAM, THROUGH THE FRAMINGHAM CITY COUNCIL, IT IS SO ORDERED:

That, at a Public Hearing held on June 21, 2022, the City Council vote to approve that the General Fund Capital Project Pearl Street Garage stairwell repairs and masonry patching, Council Order 2021-063-002 in the amount of \$235,000 be increased to \$288,910; and for the payment of costs incidental and related thereto, to be spent under the direction of the Mayor or his designee; that the Mayor is authorized to acquire by gift, purchase or eminent domain, permanent easements and temporary construction easements or other interests in land for said projects; that the Mayor is authorized to take all actions necessary or convenient to carry out the purposes of this order; and, further, to meet this appropriation, the Treasurer is authorized, with the approval of the Mayor, to issue from time to time bonds or notes in such amount pursuant to the provisions of M.G.L. Chapter 44, or any other enabling authority. Any premium received by the City upon the sale of any bonds or notes approved by this vote, less any such premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this vote in accordance with Chapter 44, Section 20 of the General Laws, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount;

And further, rescind unborrowed debt authorization for library capital projects that have been completed as follows:  
Project #32448 Voted at the 5/14 Annual Town Meeting Article 16AV Space Study Phase 2 Danforth & Annex in the amount of \$35,400  
Project #32907 Voted Council Order 2019-51-003 Long Range Building Plan Study of Danforth, Pearl St Garage, Memorial Building, Perini, and parking assessment in the amount of \$2,800.00.
