

UPON THE REQUEST OF THE CHIEF FINANCIAL OFFICER, THE PRINCIPAL ASSESSOR AND THE BOARD OF ASSESSORS, THE CITY OF FRAMINGHAM, THROUGH THE FRAMINGHAM CITY COUNCIL, IT IS SO ORDERED:

That the City Council, after hearing public input at a duly posted and advertised public hearing, votes to adopt a **Residential Factor of 0.8285/CIP Shift 1.69** for tax burden options for Fiscal Year 2024.

And, incumbent in this vote the City Council specifies that it does not adopt any of the three annual options of Open Space Class 2, Small Commercial Exemption or Residential Exemption for Fiscal Year 2024.

And further, research be made regarding the three annual options and reported back to the Council at the end of the first quarter of the next year.


