Mohawk - Chickatawbut Woods



TRAIL CLASS DESCRIPTION:

Class 4: Easy, broad, flat trails - 8 feet wide or greater,
<5% slopes

Class 3: Easy/moderate trails - 4 to 8 feet wide, rolling,
<12% slopes

Class 2: Moderate/challenging trails - 2 to 4 feet wide,
rough, less than 12% slopes

Class 1: Challenging trails - narrow and rough, less than
2 feet wide, <20% slopes

TRAIL INFORMATION:

Welcome to Mohawk - Chickatawbut Woods!

*Mohawk - Chickatawbut Woods is a **CLASS 3 TRAIL** located on 47.06-acre parcel split between the City of Framingham and Sudbury Valley Trustee that was acquired by the Conservation Commission in 1977. Originally intended to be housing, instead, it has remained undisturbed and now offers habitat for an array of flora and fauna. This conservation parcel can be accessed either from Mohawk Drive, or the end of Chickatawbut Road.*

Trails

Mohawk-Chickatawbut Woods connects land owned by the City of Framingham, Sudbury Valley Trustees (SVT) and the MA Dept. of Conservation & Recreation (DCR). This trail does not offer one main trail. Instead, it is comprised of many short and winding trails, making the potential for a different route every visit. For the best experience, users should park at the end of Mohawk Drive and begin at the trail near the pond. At the fork, continue left and make a small loop around the Meadows before continuing on into the woods and towards the Chickatawbut trail head. Users should expect to come across bridges and narrower trails.

TRAIL USE GUIDELINES

- All motorized use prohibited.
- No littering or dumping.
- Closed from dusk to dawn.
- Fires and camping are not permitted.
- No alcoholic beverages.
- Do not feed, approach, or touch wildlife.
- Take personal protection measures to reduce your exposure to ticks and mosquito bites.
- Dogs must be leashed.
- No hunting permitted at any time.


