ORDER NO. 2024-035-001 REQUEST OF THE FINANCE SUBCOMMITTEE

UPON THE REQUEST OF THE FINANCE SUBCOMMITTEE, THE CITY OF FRAMINGHAM, THROUGH THE FRAMINGHAM CITY COUNCIL, IT IS SO ORDERED:

That the Council votes to approve \$2,000,000 from the Joint Dispatch previously voted by City Council Order 2023-042-002 be rescinded so that the total amount now be \$6,000,000; and further that \$1,500,000 is appropriated for the purchase of property and building located at 196-200 Concord Street, Framingham, MA 01702; and that \$500,000 is appropriated for the design of the **Farley** Building Rooftop Solar Project, and for the payment of costs incidental or related thereto, to be spent under the direction of the Mayor or his designee; that the Mayor is authorized to acquire by gift, purchase or eminent domain, permanent easements and temporary construction easements or other interests in land for said project; that the Mayor is authorized to contract for and expend any federal or state aid available for the project, or any other funds available for the project, provided that the amount of the authorized borrowing shall be reduced by the amount of the payments of such aid or other funds received prior to the issuance of bonds or notes under this order; that the Mayor is authorized to take all actions necessary or convenient to carry out the purposes of this order; and, further, to meet these appropriations, the Treasurer is authorized, with the approval of the Mayor, to issue from time to time bonds or notes in such amounts pursuant to the provisions of M.G.L. Chapter 44, or any other enabling authority.
