By the City Council of the City of Framingham, Massachusetts Notice having been given and a public hearing held, as provided by law, **IT IS HEREBY ORDERED that**

**VERIZON NEW ENGLAND INC. and
NSTAR ELECTRIC COMPANY d/b/a EVERSOURCE ENERGY**

be and are hereby granted locations for and permission to erect and maintain poles and their respective wires and cables to be placed thereon, together with anchors, guys and other such sustaining and protecting fixtures as said Companies may deem necessary, in the public way or ways hereinafter referred to as requested in petition of said Companies dated the 7th day of October 2025.

All construction under this order shall be in accordance with the following conditions:

Poles shall be of sound timber, and reasonably straight and shall be set substantially at the points indicated upon the plan marked - Verizon No. **1A7U6WD**, dated October 7, 2025, filed with said petition. There may be attached to said poles by said **VERIZON NEW ENGLAND INC. and NSTAR ELECTRIC COMPANY d/b/a EVERSOURCE ENERGY** wires and cables which shall be placed at a height of not less than 18 feet from the ground at highway crossings, and not less than 8 feet from the ground elsewhere.


The following are the public ways or parts of ways along which the poles above referred to may be erected, and the number of poles, which may be erected thereon under this order:

EDMANDS ROAD: Place one (1) jointly owned pole numbered T.125S / E.125S on the north side of Edmands Road at a point approximately four hundred forty (440) feet northeasterly from the Southborough Town Line; and approximately thirty-five (35) feet northerly from existing pole numbered T.125 / E.125.

Reason: This request is required to correct an existing pole-to-tree guying issue; and to provide for the distribution of intelligence and telecommunications and the transmission of high and low voltage electric current.

Also, that permission be and hereby is granted to said Companies to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each may desire for distributing purposes.





Dear City Council,

The Department of Public Works (DPW) is in receipt of a request from Verizon New England, Inc. to install (1) jointly owned pole numbered T.125S/E.125S, wire, cables and fixtures, including the necessary anchors, guys and other such sustaining and protecting fixtures to be owned and used in common by your petitioners, along and across the following public way or ways of Edmands Road.

We have reviewed this Grant of Location request submitted to the City Council and recommend approval subject to the following conditions:

1. The applicant shall call Dig-safe to mark out the location of the water main before construction.
2. The proposed utility pole relocation shall be installed a minimum five feet away from City utilities. The DPW requests notification prior to the start of work to verify final location in the field.
3. All work shall conform to the City of Framingham construction standards.
4. The proposed work shall be inspected by the City of Framingham DPW to verify that no public utilities are adversely affected.
5. The area in the vicinity of the work shall be restored and all excess excavation resulting from pole setting shall be removed by the Grantee.




